## **BOOTH:**

The Feztival of Trees Marketplace does not provide tables, Wi-Fi, chairs, carpet, or extension cords. The venue will be maintained at low light levels to highlight the Christmas trees. Vendors should consider supplying additional work or display lighting for their booth(s). Booth electric charge applies.

All vendor materials must remain inside of assigned space.

Sam Houston Racetrack provides 24 hours/7 days a week security. Access to booth spaces during non- operating hours is not permitted. Firearms are not permitted on the premises for sale or carry.

## **TERMS of PAYMENT**

To reserve booth space, payment must be made in full. This payment is non-refundable after October 15<sup>th</sup>, 2023, no exceptions.

## **SUBLETTING of SPACE**

No Vendor may assign, sublet, or appropriate any part of their assigned space. Offering goods, soliciting, or taking orders on behalf of another party is prohibited.

## **LIABILITY and HOLD HARMLESS**

Vendor agrees to protect, hold harmless and indemnify The Feztival of Trees, its sponsor Arabia Shriners, their officers, directors, volunteers, and employees from any loss, damage, or injury to Vendor's goods or visitors to Vendors booth. Vendor assumes the entire responsibility for any claims, losses, damages to person or property, governmental fees or fines, attorney fees arising from or caused by Vendor's installation, removal, maintenance, occupancy, or use of the assigned space(s). Vendor further acknowledges that neither The Feztival of Trees nor, its sponsor Arabia Shriners, provides any insurance coverage for Vendor's property or liability, and it is the sole responsibility of the Vendor to obtain insurance coverage for business interruption, property damage, theft, vandalism, or other losses.

## **ERECTING and DISMANTALING of BOOTH MATERIALS**

Move-in, booth erection, booth removal and move-out are the sole responsibility of the Vendor.

## **MAXIMUM BOOTH DISPLAY SIZE**

All Vendor materials shall conform to the assigned booth space and shall not restrict visual or physical access to adjacent Vendors or infringe upon adjacent access aisle ways. Booths shall not exceed 8' in height without the written permission of the Feztival of Trees Chairman or his designated representative.

## **FOOD, DRINK and DISTRACTING ODORS and SOUNDS**

The cooking or sale of hazardous food items, as defined by the City of Houston, is prohibited. The sale and display of alcoholic beverages is prohibited. No Vendor may generate sounds, exhibit behavior or emit odors from their booth that distract or otherwise interfere with the operations of other vendors, the event or the facility. Vendor agrees that the decision to remove or relocate a booth is at the sole discretion of The Feztival of Trees Chairman, whose decision is final.

## **AMENDMENTS**

All matters not specifically covered by the preceding rules and regulations shall be subject to the sole decision of the Feztival of Trees Chairman. All amendments made hereto shall be binding on all Vendors.
